Notes:

SG-13 remains with a negative score on archaeology even though the actual working area would preserve the archaeological interest

SG-09 and SG-42 remain with negative scores and SG-33 and SG-60 have not been give negative scores on archaeology, despite South Oxfordshire archaeological restraint designation

Although the access for SG-09 and SG-59 is identified in OCC table as distant from the main lorry network, an existing farm road directly onto A4074 is to be used, not minor public roads.
